Whereas, consequent upon delinking of the Training-cum-Production Section attached to the State Directorate of Craftsmen Training, a new department namely, Department of Handicrafts, Textile & Coir has been created vide the Government Notification No. 23/1/87-GA&C (Vol.I) dated 09-05-2013;

And whereas, vide Government order No. 1-10-2013/Fin(Bud) dated 5-5-2014, the Director of Handicrafts, Textile and Coir has been declared as the Head of Department under clause (g) of rule 2 of the Goa Delegation of Financial Power Rules, 2008 for exercising the powers in Annexure VI (Power to incur contingent expenditure) under Part-I and Part-II and also the Budget Controlling Authority for the Major Head 2551, 2851 and 4851 under Demand No. 61;

And whereas, the Demand No. 69 has empowered the Director, Department of Handicrafts, Textile and Coir and he has been delegated the powers of Budget Controlling Authority under the said demand No. 69;

And whereas, the Department of Handicrafts, Textile and Coir undertakes various training programs for unemployed youth and woman in trades such as handloom, powerloom, batik, pottery, bamboo, papier machie, carpentry, coir, etc. as per the sanction/approval of the Government;

And whereas, the Department of Handicrafts, Textile and Coir is required to pay stipend//scholarship to the trainees on monthly basis as per the limit specified by the Government in various schemes;

And whereas, in terms of rule 17 of the Goa Delegation of Financial Powers, Rules, 2008, the power to sanction grant-in-aid including scholarship and loans vests with the Secretariat Administrative Department and Secretaries to the Government;
