All the Assessing Authorities shall strictly follow the guidelines, circulars, notifications, deadlines issued by the Commissioner from time to time and in this Order with reference to Assessment/ Audit/ Refund etc. Any other matter which requires attention or consideration of the undersigned shall be reported in writing or by mail for a specific order or direction.
