

Notification

No. 22/24/2013-RD

Whereas by Government Notification No. 22/24/2013-RD dated 01-10-2013 published on page No. 729 of Series II No. 28 of the Official Gazette dated 10-10-2013 and in two local newspapers (1) "The Gomantak Times" dated 04-10-2013 and (2) "Lokmat" dated 04-10-2013, it was notified under Section 4 of the Land Acquisition Act, 1894 (Central Act 1 of 1894) (hereinafter referred to as "the said Act"), that the land specified in the Schedule appended to the said Notification (hereinafter referred to as the said land), was needed for public purpose, viz. Land Acquisition for construction of Modern Fire Station at Bicholim.

And whereas, the Government of Goa (hereinafter referred to as "the Government") after considering the report made under sub-section (2) of Section 5-A the said Act is satisfied that the land specified in the Schedule hereto is needed for the public purpose specified above (hereinafter referred to as "the said land").

Now, therefore, the Government hereby declares under provisions of Section 6 of the said Act that the said land is required for the public purpose specified above.

The Government also hereby appoints under clause (c) of Section 3 of the said Act, the Dy. Collector & SDO, Bicholim, to perform the functions of the Collector for all proceedings hereinafter to be taken in respect of the said land directs him under Section 7 of the said Act to take order for the acquisition of the said land.

3. A plan of the said land can be inspected at the office of the Deputy Collector & S.D.O., Bicholim till the award is made under Section 11.
