AWARD

(Passed on this 1st day of September, 2010)

In exercise of the powers conferred under Section 10(1) (d) of the Industrial Dispute Act, the Government of Goa referred the following dispute for adjudication of this Tribunal.

- "(1) Whether the demand of the Workmen employed by M/s. Renaissance Goa Resort, Fatrade, for 20% bonus for the accounting years 1998-99, 1999-2000 and 2000-2001, is legal and justified?
- (2) If yes, what relief the Workmen are entitled to?"
- 2. Notices were issued to Party I and Party II. The statement of claim was filed by Party I vide Exb. 3 wherein the employees union has claimed that the present dispute is regarding non-payment of bonus by Party II for last two to three years even though huge profits were made by Party II for the accounting year 1996-1997 till 2000-2001. Bonus @ 20% was demanded for the workers for the accounting years 1998-1999 upto the year 2000-2001. The Party I also claimed that the original record with regard to the balance sheet profit and loss account, income tax for the accounting years shall be called from Party II in order to find out profit margin made by Party II during the said five years period.
- 3. The Party II filed written statement at Exb. 5 and resisted the claim of Party I for bonus of 20% as claimed in the demand. It is their contention that as per the Payment of Bonus Act workers are entitled to the bonus @ 8.33% of the wages and such bonus have been already paid for the accounting years and hence the demand for bonus of 20% is not maintainable. As far as other aspects are concerned Party II claimed that the company has sustained losses for the accounting year 1998-99, year 2000-2001 and the same have been disclosed in the balance sheets for the relevant

year. Since the company has sustained losses during the said accounting years, the workers are not entitled to claim higher rate of bonus than the one provided under the Act. Demand made by the union is unjustified.

- 4. The rejoinder was filed by the Party I at Exb. 6 wherein they denied contention of the Party II regarding incurring losses during the said accounting years.
- 5. Issues were framed vide Exb. 6 and thereafter evidence was laid partly by Party I. In the meantime parties were negotiating for settlement and the efforts succeeded in signing the settlement by both parties. Party II agreed to pay total sum of Rs. 2,50,000 towards full and final settlement of all claims arising out of present reference regarding bonus for the accounting years 1998-99 upto the year 200-2001. The Party I accepted the said amount as full and final settlement and accordingly application to that effect was filed at Exb. 22 alongwith the memorandum of settlement executed between the parties on Exb. 23. I found that the settlement executed between the parties is genuine one and the demand of the union regarding the bonus has been partially complied which has been accepted by the union as full and final settlement of their demand. The said terms of settlement are therefore accepted with regard to the present reference and in view of this no dispute exists between the parties. Hence the

ORDER

In view of the settlement and the memorandum filed at Exb. 23, no dispute exists between the said parties.
