The Appropriate Assessing Authority/Unit Incharge of respective dealer at local jurisdictional ward office shall immediately hand over the dealer's Assessment case records for the year 2021-22 and Registration Files, both under GVAT Act, 2005 and the Central Sales Tax Act, 1956 to the respective Assessing Officer to whom the case is assigned hereinabove. It shall be ensured that the VAT Audit Report (if any) filed u/s. 70 as also the statutory Declaration Forms (if any) and all other relevant correspondence/documents shall be handed over to the concerned Officer for completing audit assessment. The case records shall be delivered at the present place of posting of above listed Officers at the earliest and in any case on or before 31/01/2025.

The Officers indicated in column No. 5 shall be responsible to undertake the Audit Assessment of respective dealer assigned to each of them. The assessment proceedings shall be processed and completed invariably through VATSoft online system by the concerned officers. The final assessment order shall be generated, signed and issued by above listed Officers at least 30 days prior to expiry of prescribed limitation period under the GVAT Act, 2005. Upon completion of audit assessment, the entire assessment case record along with all other records shall be delivered to the Jurisdictional ward office under which the dealer is registered.

The Appropriate Assessing Authority/Unit Incharge of respective dealer at local jurisdictional ward office shall immediately serve the assessment order upon the dealer after entering the same in registers and Day Book maintained at ward office.

All the Assessing Authorities shall strictly follow the provisions of the Goa Value Added Tax Act, 2005 and the Goa Value Added Tax Rules, 2005 and the written instructions issued from time to time relating to assessments.

In case any of the above given Officers do not receive the original case records on or before 31/01/2025, then they shall report the same in writing to undersigned before 05/02/2025. Any other matters which requires attention or consideration of the undersigned shall be reported in writing for specific orders and directions.

All the Assessing Authorities shall mail a scanned copy of signed Assessment Order in each of the case to aclegal-ctax.goa@gov.in within 10 days from the date of issue of Audit Assessment Order.
